Operating a ski resort In New Jersey requires the use of snowmaking equipment. Snowmaking equipment is present on the mountain and may be located ontrail, off-trail, and on the edges and sides of trails. Please maintain control of your speed, course, and direction and. avoid contacting snowmaking equipment. Slay on-trail; that is on the groomed surface of the designated, open trails. Avoid skiing or snowboarding on the edges of the trails. Coming into contact with snowmaking equipment or skiing off-trail may result in serious injury or death.

• Snowmobiles and grooming machines are necessary for the operation of the mountain, so be aware for these types of onsnow vehicles, as they can be encountered at any time on any trail. Look and listen for the headlights, warning lights, visible flags, back-up sirens and/or motor sounds associated with snowmobiles or grooming machines.
